 - A. Arranging time and meeting location,
 - B. Planning the agenda, and
 - C. Selecting a secretary.
- II. The committee secretary is responsible for
 - A. Recording minutes of each meeting,
 - B. Listing names in minutes of present and absent committee members, and
 - C. Distributing minutes to committee members and responsible administrators including the President and the Vice President for Academic Affairs.
- III. The committee member is responsible for
 - A. Attending meeting prepared to participate in proceedings,
 - B. Submitting agenda items to chairperson, and
 - C. Informing the chairperson when absence is anticipated.

"The duties of the chairman shall be to . . . appoint all faculty committees except those elected by the faculty . . . " (from the <u>Faculty Constitution</u>). The following committees and committee assignments are authorized by the President. The President and Vice President for Academic Affairs are ex officio members of all standing or ad hoc John Brown University committees.

This document lists committees that are more institutional in nature and is not intended to include all committees that may exist at JBU. Committees created at the discretion of colleges, departments, or offices will generally not be included in this document. Search committees will also not be included.

Committee assignments are made over the summer for the following academic year. Elections for faculty elected committees take place in April at the last Faculty Meeting of the year. Faculty members are nominated through the colleges. Faculty should let college deans know if they are interested in being nominated. Changes to committee assignments may occur during the academic year, but the published version of this document will typically not be updated to reflect those changes.

I. FACULTY ELECTED COMMITTEES

CORE CURRICULUM COMMITTEE (Three-Year, Staggered Terms)

Lou Cha (2 years, at-large), Louise Cole (3 years, at-large), Suzanna Guizar (3 years), Robert Moore (1 year), Kimberly Murie (2 years), Randall Waldron (1 year), and Trisha Posey (chair). Emily Burney and an SGA appointee are non-voting members.

Each of the four colleges elects one member from within the college. Two additional at-large members are elected from the full faculty. The Dean of Undergraduate Studies chairs the committee. The Associate Registrar for Undergraduate Students and an SGA representative are non-voting members.

This committee is responsible for the oversight of the traditional undergraduate core curriculum. The committee determines that the general education outcomes are appropriately assigned to the courses in the core curriculum and that the course syllabi constructed by the instructors demonstrate that these outcomes are being addressed. Course alternatives and exceptions to the curriculum will be recommended by this committee. The committee is responsible for the on-going assessment of the effectiveness of the core curriculum. Reports to the Vice President for Academic Affairs.

DEANS COUNCIL

Members are the college deans, chair and chair-elect of the Faculty Affairs Committee, Dean of Academic Services, Dean of Undergraduate Studies, Dean of Innovation and Curriculum, and the Vice President for Academic Affairs (chair).

The council is responsible for the establishment of academic standards and policies affecting the academic programs. Reports to the President.

FACULTY AFFAIRS COMMITTEE (Three-Year, Staggered Terms)

Kyle Agee (1 year), Nick Cornett (2 years), Kim Murie (1 year, at-large), John Lee (2 years), Hepsiba Vivenkanandan (1 year), Joe Walenciak (3 years), Melanie Peddicord (chair-elect, 2 years), and Miguel Rivera (chair, 3 years).

Each of the four colleges elects two members from within the college. One additional at-large member is elected from the full faculty. The committee elects two co-chairs to one-year terms, with the co-chairs coming from different colleges. The co-chairs serve on the Deans Council.

This committee serves to facilitate communication between the faculty and the administration. Any professor or administrator may bring concerns or questions to committee members, who will then use the Faculty Affairs Committee Surveys or the Faculty Climate Survey to determine the facts and assess faculty opinion. Those results will then be disseminated and discussed through the appropriate channels. The chair and chair-elect are responsible for organizing and chairing meetings as needed and serving on the Deans Council. Some of these meetings will include available members of the President's cabinet and academic deans, for the purpose of discussing issues of importance to the faculty, and the other meetings are to be faculty only.

The JBU Strategic Plan affirms the institutional desire to reflect the diversity of God's kingdom by increasing the diversity of JBU's faculty, staff, and students. The Faculty Affairs Committee actively seeks to manifest this desire through committee member representation and in its representation of faculty to the Deans Council.

These elected representatives also serve as representatives of the faculty at the committee meetings of the JBU Board of Trustees at their regular on-campus meetings in October and April. The co-chairs will be invited to other trustee meetings and functions as warranted. Reports to the President.

FACULTY DEVELOPMENT COMMITTEE (Three-Year, Staggered Terms)

Each of the four colleges elects two members from within the college. The director of faculty development chairs the committee.

JBU Faculty Development works to provide opportunities for faculty to gather in community to learn from one another and to learn from diverse perspectives, and in accordance with JBU's Head, Heart and Hand philosophy, supports our faculty in the areas of scholarship, spiritual growth and modeling, and teaching excellence in the classroom. The Faculty Development Committee supports this mission by overseeing the disbursal of faculty development grant funds, selecting recipients for competitive grant programs, suggesting faculty development events, giving input into the Fall Faculty Workshop, and providing general advice on all aspects of faculty development. Reports to the Vice President for Academic Affairs.

FACULTY STATUS COMMITTEE (Three-Year, Staggered Terms)

Each of the four colleges elects two members from within the college. The chair of the committee is a faculty member appointed by the president from a slate nominated by the faculty. Faculty committee members must have at least Associate Professor rank and have at least five years of service at JBU. The university chaplain is also on the committee.

This advisory committee interviews all faculty-level employee candidates to help assess a candidate's faith commitment and to ensure an appropriate institutional fit. Reports to the Vice President for Academic Affairs.

This committee oversees all institutional and program-level assessments in use at JBU. This committee recommends a master assessment plan, shares comprehensive results with the university community, and recommends appropriate action based upon that information. The committee also provides feedback on program reviews and organizes the Assessment Summit. Reports to the President.

CHEMICAL HYGIENE COMMITTEE

The committee provides help and guidance to the Chemical Hygiene Officer as needed. Reports to the Chief Operating Officer.

The sub-committees (Department of Teacher Education & the PDS Facilitators) take the initiative in all matters pertaining to teacher education: criteria for admission to the program and internship, regulations, assessments, changes in professional courses, program additions, and changes in program components. The PDS Advisory Committee critiques and confirms any of the above components that are to be established. The PDS Advisory Committee recommends changes and the sub-committees develop the recommendations for the Committee to critique and approve. Reports to the Vice President for Academic Affairs.

SCHOLASTIC PETITIONS COMMITTEE
